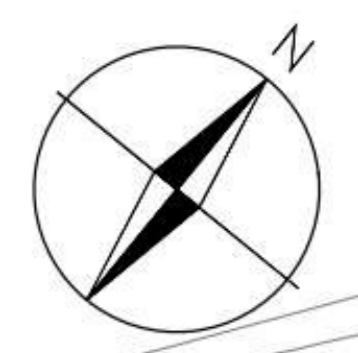

- Landscape Layout key:**
- Contract Boundary
 - Non Material Amendments
 - Existing trees and hedgerows to be retained and protected during the works.
 - Proposed ornamental planting on 400mm depth of topsoil with 75mm bark mulch.
 - Proposed climbers with climber wires on 400mm depth of topsoil with 75mm bark mulch.
 - Proposed native tree planting, tree pit and stake as detailed in the specification.
 - Small ornamental tree/ large shrub planting, tree pit and stake as detailed in the specification.
 - Proposed mixed native hedgerow planted in a double staggered row at 0.4m centres. Bare root transplants with 60cm rabbit guards.
 - Proposed single species hedgerow planted in a double staggered row at 0.4m centres. Bare root transplants with 60cm rabbit guards.
 - Front gardens to be turfed on 150mm topsoil.
 - Public open space to be sown with Geminal Aber-Sustain mix, or similar approved, to be sown at a rate of 40g/m² on 150mm topsoil.
 - Native tree / shrub planting to be planted as 60-80cm whip planting at 0.7m centres, for additional wildlife habitat.
 - Grassland to public open space to be retained and overseeded with Geminal Aber-Sustain mix, or similar approved, to be sown at a rate of 20g/m².
 - Public open space to be sown with Geminal Eco Species Rich Lawn mix, or similar approved, to be sown at a rate of 10g/m² on 150mm topsoil.
 - Mown grass footpath strip 1m wide on Geminal Eco Species Rich Lawn mix, or similar approved, to be sown at a rate of 10g/m² on 150mm topsoil.
 - Wildflower seeding, WF19 Pollinators Paradise, to the public open space to be sown at 2g/m² planted into 200mm of a mix of topsoil and similar (50:50).
 - Mixed native bulb planting

- Boundary key:**
- 1.8m high screen wall/fence
 - 1.8m high timber close boarded fence
 - 2.4m acoustic fence

- Paving Key:**
- Main roads, shared driveways & footpaths, including raised feature junctions and ramp/transition strips to be tarmac.
 - Private Drive - Private drives and parking spaces in Mona Precast Monopave concrete block paving in 'Bridle' with contrasting blocks in 'Charcoal' to demarc parking spaces or similar approved.
 - Private pathways and patios to be Mona PreCast Monopave Slab concrete paving slabs in 'Buff' or similar approved.
 - Hoggin path to follow existing footway. Hoggin self binding gravel 150mm to dust. Wooden edging is to be used.
 - Gravel areas - 200mm limestone chippings or similar approved.

Note: Local Equipped Area for Play (LEAP) and Local Area for Play (LAP) refer to streetscape design.
